

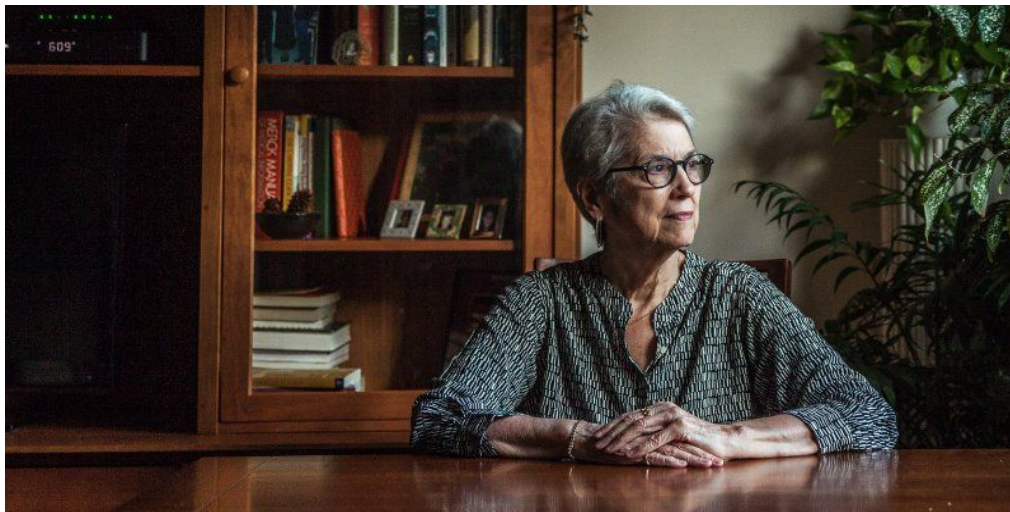
TRUMP SEXUAL MISCONDUCT TIMELINE

JURISDICTION:

1. This action is brought pursuant to 42 U.S.C. 1985 (2) (3), 42 U.S.C. 1986, Ninth and Thirteenth Amend Constitution. Jurisdiction is founded on 28 U.S.C. 1331, 1332 and 1343 (3)(4) on the basis of diversity of citizenship. Plaintiff is a resident of the State of Florida and the defendant Trump is a resident of the State of New York and defendant Wagner are residents of the State of New Jersey.

2. Plaintiff invokes the pendent jurisdiction of this Court pursuant to 28 U.S.C. 1367 to adjudicate state law of the State of New York Civil Rights Law, Sec. 40-e, the laws and constitution of the State of Florida, prima facie "outrageous conduct," defamation and intentional infliction of emotional distress.
